## **Speakers**



Morning Keynote Speaker - Philip C. Marshall helps advance elder justice through advocacy, training, select projects, and fostering multi-disciplinary partnerships. Philip is the grandson of the late Brooke Astor, New York City philanthropist—and a victim of elder abuse by her son. Marshall taught and practiced historic preservation for forty years.



**Afternoon Keynote Speaker** – **Debbie Deem**, a former FBI Victim Specialist and current Financial Abuse Specialist Team (FAST) Coordinator for Ventura County, CA, is a longtime advocate for chronic victims of fraud targeting vulnerable adults. She has organized multidisciplinary teams to combat these 'forgotten crimes' and support their victims. She has trained financial exploitation responders from the local level to the international level

and has authored articles on the victims of financial and cyber-crime, including most recently the Neuroscience of Financial Scams with Dr. Lande for the DOJ, Elder Justice Initiative.



Amber Evans is the Memory Care and Engagement Specialist for LCB Senior Living. She is a Licensed Clinical Mental Health Counselor and a Registered Dance/Movement Therapist, who specializes in nonpharmacological and expressive art interventions for people living with dementia, as well as for their families. Amber is also a Certified Dementia Practitioner, as well as a Board Certified Dementia Educator for the National

Institute for Dementia Education and provides quality and comprehensive training and education to health care professionals in the new England area and beyond. Amber's passion is working with residents and care givers to provide high quality of life, dignity and purpose, amidst a dementia diagnosis.
